Introduction

As part of the Port of Corner Brook Cruise Welcome Program, we invite musicians to provide entertainment for cruise guests throughout the 2024 season. The outdoor performance stage is positioned adjacent to the vendor market on the south end of the dock. The wooden stage is enclosed on three sides with an overhead canopy and provides performer(s) approximately 100 square feet of space. There is an electrical hook-up available.

Scope of Services

It is the responsibility of the musician(s) to set/takedown their equipment. Access to the port's restricted area on the day of performance is limited to once the vessel is secured and 30 minutes following the ship's scheduled departure time. Vehicles are not permitted in the restricted area, except as expressly permitted by the Operations Manager or his designate.

Corner Brook Port Corporation does not supply musical equipment including microphones, speakers, stands or instruments to successful applicants.

Cancellation Policy

In case of a ship cancellation before the scheduled arrival date, the Corporation shall not assume liability for any expenses related to the entertainment service. However, if the cancellation occurs on the day of the scheduled arrival, the Corporation will provide compensation in the form of a fixed rate of \$100.00.
